November 16, 2021

The monthly meeting of Rural Water District #9 was held on Tuesday, November 16, 2021, at the District Office. Members attending: Craig Lohman, Ed Mullins, Don Kirby, Jamie Moore, Jim Armstrong, Inge White, Manager Karen Armstrong, Operator Wayne Wrosch. Also present was Engineer Louis Funk of Bartlett and West.

The meeting was called to order by Chairman C. Lohman at 1831.

1. Minutes

A motion to approve the minutes of the October 19, 2021, meeting was made by Moore, seconded by Kirby. Motion passed unanimously.

2. Public Opportunity

Louis Funk presented Board members with Groundwater Investigation results and options. Discussions re: well locations, protective radius, water quality, water quantity, and financial considerations.
